CH, RU, and 3<sup>rd</sup> honors only in all events

\* This is an invitational tournament and the management reserves the right to modify the program at any time, and reject, refund or disqualify any contestant whom in its judgment interferes with the safe conduct or sportsmanship of the tournament. Harassment or abuse of trap personnel will result in disqualification.

\* Orange dome targets will be used. Traps will be set with radar gun before each event. Traps may be rechecked at any time by squad request. Significant target variations will be corrected by the shoot director or trap committee.

\* The Club will be open at 8:00 a.m. on Saturday and Sunday for registration and practice.

\* Lunch and Drinks will be provided Saturday and Sunday.

\* Practice will be available during the shoot for \$4.00 per round.

\* The required ATA fee of 3.00 and NMSTA fee of 4.00 will be charged on the first event shot each day.

**GENERAL CLASSIFICATION**

Classification will be based on official averages, known ability and last 500 targets. Shooters with no established average will be placed in not less than Class B in Singles & Doubles, and not less than the 20 yard line in Handicap. Ladies and Sub-Juniors with no established average will be placed in not less than Class C and not less than the 19 yard line in Handicap. Male shooters upon becoming 15 years old will be assigned a handicap of not less than 20 yards.
