#### 7.0 Facility Grounds Care

- **7.1** There are eight more benches that need to be installed on the skeet fields. Another work day will be scheduled to complete these.
- 7.2 The camera security system is not working properly. Organ Mountain Cable Company is still working on the issue. We replaced the router/gateway last Thursday and it helped some. OMCC sent a tech out the week of 8/11/25. 3 cameras were not working. The tech was only able to reset two of the cameras because he did not bring a ladder with him to reach one of them. The issue is still unresolved. One camera is still not working. OMCC has not responded since their last visit? Jason said he would talk to them.
- 7.3 Phillip and Karen have mowed and trimmed the trap fields the last two times, prior to that it was Phillip and Randy. If you're willing to help with the next one please contact Phillip. Brock said he knows a company that might handle it for us. He said he would schedule a meeting.
- **7.4** Preston said some of the picnic tables/benches need to be replaced. Some are weathered and cracked and could be dangerous.

- 4. Figure out a new trash disposal system at trap and skeet ranges. 7/3/25 update; The city is currently handling our skeet and trap trash cans. Still working great as of 8/7/25.
- 5. Replace the door knobs on the skeet fields. (Completed)
- **8.3** The next target delivery date should be after our NM State skeet shoot and before our first big shoot in January 2026, 10/25/2025 1/3/2026.
- **8.4** MVSS was approached by a wholesaler and they offered us some decent prices on shotgun ammo by the pallet. Average price would be \$8.00 per box of 25 plus tax. Phillip will get an email out to the members and ask if they are interested. The minimum order would be one flat (case of 10 boxes).
- **8.5** Preston said he has one or two companies interested in advertising on the barbed wire fence that separates the shotgun range and the frontage road. Phillip will reach out to the City for approval to proceed.
- **8.6** Rick would like to purchase an AED Defibrillator machine and place it in the main house. Bob K. said he had one that he would loan to MVSS. Rick could train the 5 or 6 main people that open the range.
- **8.7** Ethan from the NMSU shooting team would like a donation from MVSS. We would gladly support them. However, there are issues with their club status with NMSU and their finances. Until that is ironed out, MVSS will hold off on any donation.
